2.6) By default, just typing out a search phrase eg Judicial Review, will give you results of the exact phrase first. Alternatively, users may use quotation marks " "eg. "Judicial Review".



2.7) Search by using + and - to refine results. eg. murder + gun - knife will give the results for cases with the words murder and gun in them, but will not include results with the word knife.
